

DISTRIBUTOR TERMS & CONDITIONS

Last Updated: August 2026

These Distributor Terms & Conditions apply to all individuals and businesses approved to distribute Kanye Kings Stem Cell SA products.

By applying to become a distributor, placing a distributor order or representing yourself as an authorised Kanye Kings distributor, you agree to comply with these terms.

1. About Kanye Kings Stem Cell SA

For the purposes of these terms, “Kanye Kings”, “we”, “us” and “our” refer to Kanye Kings Stem Cell SA.

“Distributor”, “you” and “your” refer to any person or business approved to purchase and resell Kanye Kings products under the distributor programme.

2. Distributor Approval

Submitting an application does not automatically make an applicant an authorised Kanye Kings distributor.

All applications are subject to review and approval.

Kanye Kings may consider factors such as:

- Location
- Existing distributor coverage
- Business experience
- Intended sales channels
- Suitability of the applicant
- Ability to represent the Kanye Kings brand responsibly
- Compliance with applicable laws and these terms

Kanye Kings reserves the right to accept or decline an application at its discretion.

3. Distributor Status

Approved distributors operate as independent businesses or individuals.

A distributor is not:

- An employee of Kanye Kings
- A partner of Kanye Kings
- An agent authorised to bind Kanye Kings
- A franchisee
- A shareholder
- A representative authorised to make commitments on behalf of Kanye Kings

Distributors are responsible for their own business activities, taxes, expenses, licences and legal obligations.

4. Distributor Pricing

Approved distributors may receive access to distributor pricing.

Distributor pricing:

- Is confidential
- May differ from retail pricing
- May change from time to time
- Is available only to approved distributors
- May be subject to minimum order quantities or minimum order values

Distributor pricing may not be shared publicly unless Kanye Kings has provided written approval.

5. Minimum Orders

Minimum order quantities or values may apply.

Kanye Kings may change minimum order requirements by providing reasonable notice to distributors.

6. Orders

Distributor orders must be placed through an approved Kanye Kings ordering channel.

Orders are subject to:

- Product availability

- Delivery availability

An order is only confirmed once Kanye Kings has accepted the order and payment requirements have been satisfied.

7. Payment

Distributor orders must be paid according to the payment terms provided by Kanye Kings. Unless otherwise agreed in writing, payment may be required before orders are processed or dispatched.

Accepted payment methods:

8. Delivery and Collection

Delivery charges may apply to distributor orders.

Delivery costs depend on:

Where collection is available, distributors may collect orders from an approved Kanye Kings collection point during the applicable trading hours.

Distributors are responsible for confirming that delivery information is accurate before an order is dispatched.

9. Product Inspection

Distributors should inspect products as soon as reasonably possible after receiving an order. Any damaged, missing or incorrect items should be reported to Kanye Kings promptly.

Claims should include:

- Invoice or order number
- Product name
- Quantity affected
- Description of the issue
- Photographs where appropriate

Kanye Kings may request the return of affected products before providing a replacement or credit.

10. Product Storage

Distributors are responsible for storing Kanye Kings products according to the storage instructions provided.

Products must be protected from:

- Excessive heat
- Direct sunlight
- Moisture where applicable
- Contamination
- Damage
- Conditions that may affect product quality

Distributors may not knowingly sell products that have been improperly stored, damaged or compromised.

11. Expiry Dates and Product Rotation

Where products have expiry or best-before dates, distributors are responsible for checking dates and managing stock responsibly.

Older stock should generally be sold before newer stock where appropriate.

Expired products may not be sold.

Kanye Kings is not responsible for losses caused by poor stock rotation unless otherwise agreed in writing.

12. Resale of Kanye Kings Products

Distributors may only sell genuine Kanye Kings products obtained through authorised channels.

Products may not be:

- Altered
- Repackaged
- Diluted
- Relabelled
- Modified
- Tampered with
- Combined into another product for resale without written approval

Original product labels, batch information, usage instructions and warnings must remain intact.

13. Retail Pricing

Kanye Kings may provide recommended retail prices.

Unless specifically permitted by law and agreed contractually, distributors remain responsible for determining their own resale prices.

Distributors should not market Kanye Kings products in a way that damages the brand, misleads customers or creates false impressions regarding product value.

Any promotional pricing must comply with applicable consumer legislation.

14. Approved Sales Channels

Distributors may sell Kanye Kings products through approved channels, which may include:

- Physical retail outlets
- Direct customer sales
- Wellness businesses
- Events
- Approved websites
- Approved social media channels
- Other channels authorised by Kanye Kings

Distributors must comply with any channel-specific guidelines issued by Kanye Kings.

15. Online Sales

Distributors wishing to sell Kanye Kings products online must ensure that product information is accurate and consistent with approved Kanye Kings information.

Online listings must not contain:

- Unapproved medical claims
- Misleading health claims
- Altered ingredient information
- False product benefits
- Unauthorised certification claims
- Misleading comparisons
- Incorrect directions for use

Kanye Kings may request that incorrect or misleading online content be removed or amended.

16. Online Marketplaces

Selling Kanye Kings products on third-party marketplaces such as Takealot, Amazon, Facebook Marketplace or similar platforms may require prior written approval.

17. Marketing and Advertising

Distributors may promote Kanye Kings products using approved information and marketing material.

Distributors may not create or publish advertising that:

- Makes false or misleading claims
- Misrepresents product ingredients
- Guarantees health outcomes
- Claims that products cure, prevent, diagnose or treat disease without lawful authorisation
- Misrepresents SABS testing
- Misrepresents the meaning of “stem cell”
- Creates the impression that Kanye Kings provides medical stem cell treatment
- Uses unapproved before-and-after claims
- Misrepresents customer testimonials

All advertising must comply with applicable South African laws and advertising requirements.

18. Health and Product Claims

Distributors must communicate Kanye Kings products as wellness products.

Distributors may not state or imply that Kanye Kings products:

- Cure diseases
- Treat medical conditions
- Replace medication
- Replace medical procedures
- Provide medical stem cell therapy
- Guarantee specific health outcomes

Distributors should encourage customers to seek appropriate medical advice where relevant.

19. Use of the Term “Stem Cell”

The term “**Stem Cell**” forms part of the Kanye Kings Stem Cell SA brand and product terminology.

Distributors must not represent Kanye Kings products as containing human stem cells or as being equivalent to medical stem cell therapies unless Kanye Kings has provided documented approval for a specific statement.

20. SABS References

Distributors may only refer to SABS testing using wording approved by Kanye Kings.

Distributors may not state or imply that SABS:

- Endorses Kanye Kings
- Recommends Kanye Kings products
- Guarantees medical benefits
- Certifies claims not covered by the applicable testing

Any reference to SABS must accurately reflect the testing documentation held by Kanye Kings.

21. Approved Marketing Material

Kanye Kings may provide distributors with approved:

- Product photographs
- Logos
- Flyers
- Product descriptions
- Social media content
- Promotional material
- Brand guidelines

Distributors should use approved material wherever possible.

Alterations that materially change product claims, brand presentation or regulatory information are not permitted without approval.

22. Brand Usage

Kanye Kings retains ownership of its brand assets and intellectual property.

This includes:

- Kanye Kings name
- Logos
- Product names
- Wonder Fusion branding
- Product photography
- Packaging designs
- Website content
- Marketing material
- Graphics
- Written content

Distributor approval grants limited permission to use approved brand assets only for authorised resale and promotion of Kanye Kings products.

It does not transfer ownership of any intellectual property.

23. Distributor Business Names and Pages

Distributors may not create a business name, social media page, website or marketing identity that could reasonably create the impression that they are the official Kanye Kings head office.

Where Kanye Kings is included in a page or account name, wording should clearly identify the business as an independent distributor where required.

Kanye Kings may request changes to branding that creates confusion.

24. Social Media

Distributors using social media to promote Kanye Kings products must:

- Use accurate product information
- Avoid misleading claims
- Clearly distinguish personal opinion from official company information
- Follow approved brand guidelines
- Remove incorrect content if requested
- Avoid conduct that could reasonably harm the Kanye Kings brand

Kanye Kings may require distributors to amend or remove content that breaches these terms.

25. Customer Reviews and Testimonials

Distributors may share genuine customer reviews where appropriate permission has been obtained.

Reviews must not be:

- Fabricated
- Altered in a misleading way
- Presented as guaranteed results
- Used to make unlawful medical claims

Individual experiences should not be presented as typical or guaranteed outcomes.

26. Distributor Territories

Distributor approval does not automatically grant exclusivity over a geographical area.

Unless otherwise agreed, distributors are responsible for developing and managing their own customer base.

Kanye Kings is not required to provide customer leads.

Customer information obtained independently by Kanye Kings remains the property and responsibility of Kanye Kings.

Distributors must comply with applicable privacy laws when collecting or processing customer information.

28. Data Protection

Distributors must handle customer information responsibly and in accordance with applicable privacy legislation, including POPIA where applicable.

Personal information must not be:

- Sold
- Misused
- Shared without lawful reason
- Used for unrelated marketing without appropriate permission

Distributors are responsible for their own privacy practices and systems.

29. Customer Service

Distributors are expected to communicate professionally and accurately with customers.

Questions relating to medical conditions, medication, pregnancy or other individual health concerns should be referred to an appropriately qualified healthcare professional.

Distributors must not provide medical diagnoses or present themselves as healthcare professionals unless independently qualified to do so.

30. Returns From Distributor Customers

Each distributor is responsible for managing customer returns in accordance with applicable consumer law and any Kanye Kings distributor return guidelines.

A distributor may not promise refunds, replacements or compensation from Kanye Kings without approval.

Where a product quality issue is suspected, the distributor should contact Kanye Kings with the relevant product and batch information.

31. Product Recalls

If Kanye Kings issues a product recall, distributors must cooperate fully.

This may include:

- Immediately stopping sales
- Identifying affected stock
- Contacting customers where appropriate
- Returning products
- Following Kanye Kings instructions
- Removing affected listings or advertising

Distributors may not continue selling recalled products.

32. Compliance With Law

Distributors are responsible for complying with all laws and regulations applicable to their own business activities.

This may include requirements relating to:

- Consumer protection
- Advertising
- Taxation
- Business registration
- Ecommerce
- Privacy
- Product sales
- Health and wellness advertising

Distributor approval does not mean Kanye Kings assumes responsibility for a distributor's independent legal obligations.

33. Taxes

Distributors are responsible for their own:

- Income tax
- VAT obligations where applicable
- Business taxes
- Accounting
- Financial records

Kanye Kings does not provide distributors with personal tax advice.

34. Confidential Information

Distributor pricing, internal documentation, business information, unreleased products and other information identified as confidential must not be disclosed without permission.

This obligation may continue after the distributor relationship ends.

35. Conduct

Distributors are expected to represent Kanye Kings responsibly.

The distributor relationship may be reviewed or terminated if a distributor engages in conduct including:

- Fraud
- Misrepresentation
- Abusive customer treatment
- Repeated misleading health claims
- Unauthorised brand use
- Selling counterfeit or altered products
- Serious reputational misconduct

- Breach of these terms

36. Prohibited Activities

Distributors may not:

- Recruit people using false income promises
- Guarantee financial returns
- Misrepresent the distributor programme as employment
- Sell counterfeit Kanye Kings products
- Alter product packaging
- Make unauthorised therapeutic claims
- Falsify SABS information
- Misrepresent themselves as Kanye Kings head office
- Use Kanye Kings intellectual property for unrelated businesses
- Supply products in circumstances prohibited by law

37. Earnings and Income

Kanye Kings does not guarantee that a distributor will earn a particular amount of income.

Distributor performance depends on factors including:

- Sales activity
- Customer demand
- Location
- Business experience
- Marketing
- Expenses
- Product availability

Any income examples provided are illustrative only and should not be interpreted as guaranteed earnings.

38. Transfer of Distributor Status

Distributor status may not be sold, transferred or assigned to another person or business without written approval from Kanye Kings.

If the ownership or control of a distributor business changes, Kanye Kings may require a new application.

39. Suspension

Kanye Kings may suspend a distributor account while investigating:

- Unpaid accounts
- Customer complaints
- Suspected fraud
- Misleading advertising
- Product tampering
- Brand misuse

- Breaches of these terms

During suspension, distributor pricing or ordering access may be temporarily withdrawn.

40. Termination

Either party may end the distributor relationship.

A distributor may request termination by notifying Kanye Kings in writing.

Kanye Kings may terminate distributor status where:

- These terms are materially breached
- Payments remain outstanding
- Fraud or misrepresentation occurs
- Product or brand integrity is compromised
- The distributor repeatedly makes prohibited claims
- The distributor conducts business unlawfully
- Continued association poses a reasonable reputational or commercial risk

Serious breaches may result in immediate termination.

41. Effect of Termination

When distributor status ends, the distributor must stop representing themselves as an authorised Kanye Kings distributor.

The distributor may also be required to:

- Remove authorised distributor wording
- Stop using restricted marketing material
- Remove Kanye Kings branding from business pages where required
- Settle outstanding amounts
- Return confidential information

Any right to use Kanye Kings branding under the distributor programme ends upon termination.

42. Remaining Stock After Termination

Treatment of remaining stock following termination will depend on the circumstances and applicable law.

44. Limitation of Liability

To the extent permitted by applicable law, Kanye Kings is not responsible for losses arising solely from:

- A distributor's independent business decisions
- Unauthorised health claims
- Incorrect product information supplied by a distributor
- Poor stock management
- Unlawful advertising
- Unauthorised discounts
- Customer information mishandled by a distributor
- Business expenses incurred independently by the distributor

Nothing in these terms excludes liability that cannot lawfully be excluded under South African law.

45. Indemnity

To the extent permitted by law, a distributor may be held responsible for losses or claims arising from their own unlawful conduct, unauthorised product claims, product tampering, misrepresentation or material breach of these terms.

This provision does not limit any statutory protections that cannot lawfully be excluded.

46. Disputes

If a dispute arises, both parties should first attempt to resolve the matter through direct communication.

If the matter cannot be resolved informally, it may be dealt with according to applicable South African law and any dispute process agreed between the parties.

47. Governing Law

These Distributor Terms & Conditions are governed by the laws of the **Republic of South Africa**.

48. Acceptance of Terms

By submitting a distributor application, accepting approval or placing an order using distributor pricing, you confirm that you have read and agree to these Distributor Terms & Conditions. For online applications, the following checkbox should be included:

“I have read and agree to the Kanye Kings Stem Cell SA Distributor Terms & Conditions.”

Distributor applicants should not be able to submit the application without confirming acceptance.
